1. Vendors must agree to sell items during the hours specific to scheduled day(s).

Set-up is NO EARLIER than 7:00am, Selling begins at 9:30am.

2. Vendors must agree to NOT break down early (prior to 2:30pm) unless given permission from the Recreation Director.
3. Show Ups will not be granted approval to participate.

4. Vendors must ensure their areas are cleaned up before leaving the site.
5. Vendors are solely responsible for all required permits. (Health Department, etc.)
6. Borough provides space(s) only- All equipment such as tables, chairs, canopies, extension cords, etc. must be provided by the vendor.
7. Vendors must agree to set up in the space(s) assigned to them – ***NO EXCEPTIONS***
8. Vendors must agree that the Borough (Recreation Department) reserves the right to limit the number of vendors, spaces per vendor, types of vendors (and product), and vendor space locations.
9. ***Vendor disputes will NOT be tolerated and will result in immediate PERMANENT expulsion from the market without a refund of fees.***
