**NEW BUSINESS**

**a) Review 4<sup>th</sup> Quarter Report for FY 2024**

Coordinator Jankowski reviewed the report to be submitted to the County for Quarter 4 and discussed the items that will be reimbursed for the County.

Council Member Amabile asked Chair Toth about the vendor for Kite Night and potentially using Municipal Alliance funds for it. It was discussed that the Kite Night vendor would cost approximately \$12,000 and the Borough is only reimbursed for \$6,668.

Coordinator Jankowski also discussed that at the County Coordinator meeting she asked County representatives about the process for receiving additional funding, and it was relayed to her that

b) **Discussion of FY 2025 Grant Submission**

Coordinator Jankowski briefly updated the Committee that the Borough's submission for FY 2025 was approved.

It was discussed that a popcorn may have been purchased with Municipal Alliance funds in the past and would be good to use for the movies. Coordinator Jankowski to research if one was purchased and where it is.

Chair Toth asked if the Borough was still eligible for the DMHAS grant. Coordinator Jankowski discussed that the Borough had opted out of the grant due to lack of responsiveness from Central Regional at the time. Coordinator Jankowski discussed that she was under the impression the grant was for a set time period and was not continuously funded. Coordinator Jankowski would follow up with the County for more information.
