

**ORDINANCE NO. 2025-09**

**AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK,  
COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING  
AND SUPPLEMENTING ORDINANCE OF THE BOROUGH OF  
SEASIDE PARK, FIXING AND DETERMINING SALARIES  
AND WAGES OF CERTAIN OFFICIALS AND EMPLOYEES**

**BE IT ORDAINED**, by the governing body of the Borough of Seaside Park, County of Ocean, State of New Jersey, as follows:


**SECTION 1.** All previously adopted salary ordinances of the Borough of Seaside Park are hereby repealed by the Borough Council and superseded by this salary ordinance for the purpose of establishing the salaries, wages and compensation of the officers, employees, and members of the Governing Body as set forth on Schedules A, B, C, D, E, and F attached hereto and made a part of this Ordinance.

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.


**SECTION 4.** This ordinance is not legislative in nature and does not need to be codified in the Code of the Borough of Seaside Park, Ocean County, New Jersey.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law.
