**AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK, COUNTY
OF OCEAN, STATE OF NEW JERSEY, AMENDING CHAPTER 435
ENTITLED “VEHICLES AND TRAFFIC”**

WHEREAS, the Governing Body of the Borough of Seaside Park wishes to permit handicap individuals to safely and efficiently access their homes from municipal streets; and

WHEREAS, pursuant to the authority granted in N.J.S.A. 39:4-197.5 and N.J.S.A. 39:4-197.6, the Borough of Seaside Park may, by ordinance, establish a restricted parking zone in front of residences occupied by a handicapped person; and

WHEREAS, pursuant to Section 435-54 of the Code of the Borough of Seaside Park, the Governing Body may establish permitted parking spaces in front of residences occupied by a handicapped person.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Seaside Park, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 435-55 of the Code of the Borough of Seaside Park entitled “Schedule XI. Restricted Parking Spaces for Handicapped Persons Designated” is hereby amended by deleting all locations as currently described.

SECTION 2. Section 435-55 of the Code of the Borough of Seaside Park entitled “Schedule XI. Restricted Parking Spaces for Handicapped Persons Designated” is further amended by adding the following locations as described:

In the event that any portion of this Ordinance is found to be invalid for any reason by a court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the Ordinance actually adjudged to be invalid, and the remaining portions of this Ordinance shall be deemed severable therefrom and shall not be affected.

SECTION 5. This Ordinance shall take effect upon final passage and publication in accordance with law.
