Vendor Rules & Regulations

PLEASE READ THE FOLLOWING CAREFULLY

- 1. Vendors must agree to sell items during the hours specific to scheduled day of the event (July 19)
- 2. Vendors must agree to NOT break down early unless given permission from the Recreation Director.
- 3. Vendors must ensure their areas are cleaned up before leaving the site.
- 4. Vendors are solely responsible for all required permits . (Health Department, **Fire Dept** etc.)
- 5. Borough provides space(s) only- All equipment such as tables, chairs, canopies, extsion cords, etc must be provided by the vendor. No electricity or water will be provided.
- 6. Vendors must agree to set up in the space(s) assigned to them *NO EXCEPTIONS OR SPECIAL REQUESTS*
- 7. NO APPLICATIONS WILL BE ACCEPTED THE DAY OF THE FESTIVAL.
- 8. No spots will be held without payment.
- 9. Any vendor showing up the day of the event without a prepaid application will not be granted access to participate.
- 10. Applications received after July 7th will be surcharged \$50. ALL FEES ARE NON-REFUNDABLE.
- 11. Weather is beyond our control, the festival may proceed during inclement weather and the Borough reserves the right to designate a rain date as late as the morning of the Festival.
- 12. Vendors must agree that the Borough (Recreation Department) reserves the right to limit the number of vendors, spaces per vendor, types of vendors (and product), and vendor space locations.
- 13. Vendor disputes will NOT be tolerated and will result in immediate PERMANENT expulsion from the market without a refund of fees.
