HOLD HARMLESS AND INDEMNIFICATION AGREEMENT

BETWEEN **BOROUGH OF SEASIDE PARK**, a municipal corporation of the State of New Jersey, having offices at 1701 North Ocean Avenue, Seaside Park, NJ 08752 AND

Outside Organization utilizing Municipal Property or Facilities

In consideration of the use of municipal property or facilities on _____, 20____ the undersigned Outside Event Organizer/Participant agrees to the following: All activities conducted on or at municipal property or facilities by the Event Organizer/Participant shall be at the risk of the Event Organizer/Participant. The Event Organizer/Participant agrees to indemnify and hold harmless the Borough of Seaside Park, its officers, agents, and employees against and from any and all liability, claims, fines, suits, losses, demands, actions, damages and costs of any kind and nature, including reasonable attorney's fees, arising out of the use and occupation of or activities on municipal property or facilities by this Outside Event Organizer/Participant, its agents, officers, employees, invitees or guests.

The undersigned understands and acknowledges that this hold harmless and indemnification agreement requires that Seaside Park be indemnified from any losses or damages resulting from the acts or omissions from any guest, participant, visitor, or other person attending the event referred to in this agreement. This indemnification provided by the Event Organizer/ Participant includes indemnification for any alleged fault or negligence on the part of Seaside Park, its officers, agents or employees.

The undersigned further agrees to furnish Seaside Park with a Certificate of Insurance naming the Borough of Seaside Park as an Additional Insured party. The Certificate of Insurance must evidence the provision of general liability, bodily injury and property damage coverage with minimum limits of liability not less than \$1,000,000 single incident/\$2,000,000 aggregate. Coverage must include Liquor Liability and Athletic Activities. The Event Organizer/Participant's Certificate of Insurance will have provisions that their insurance is Primary and Non-Contributory and a Waiver of Subrogation against the Borough of Seaside Park, its officers, agents and employees.

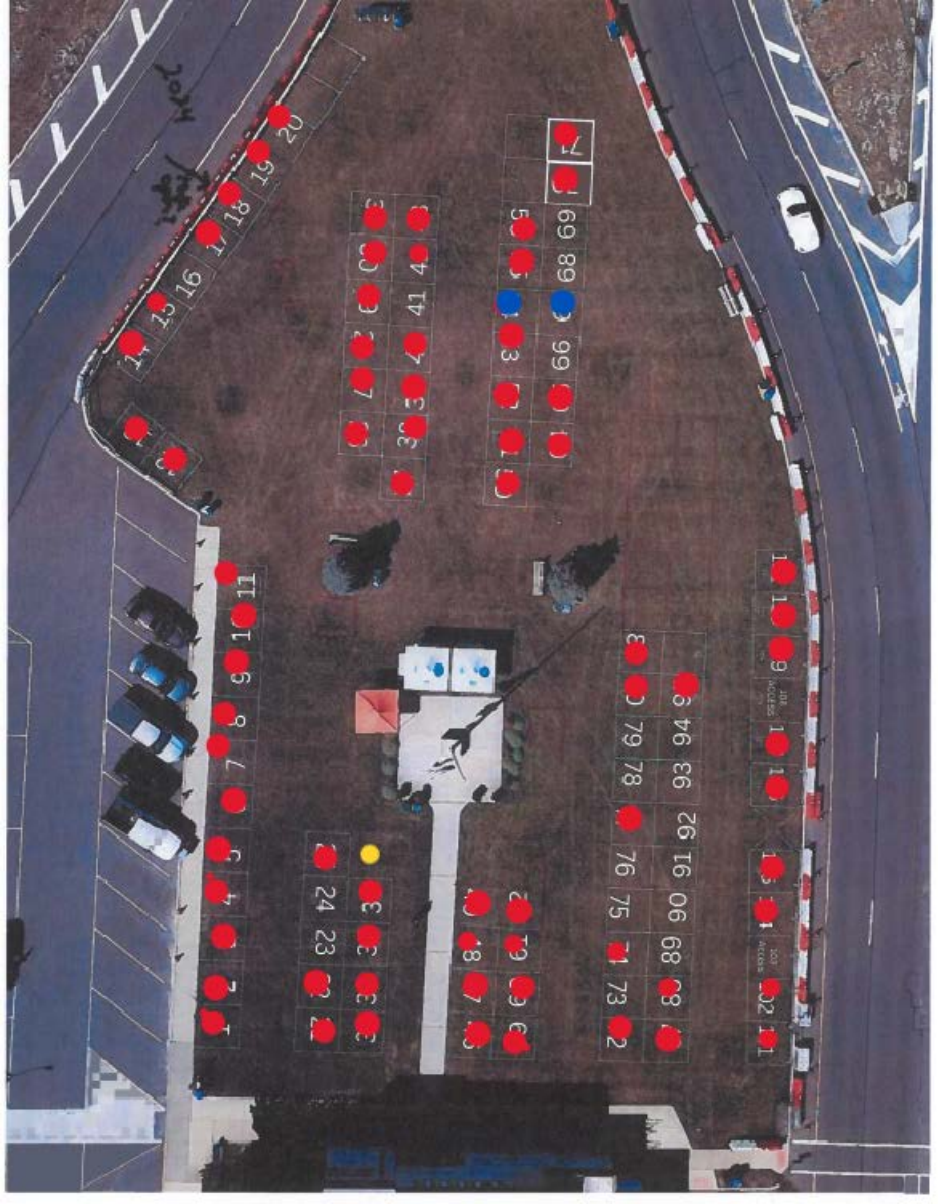
