

I will offer the sale of only the items indicated above. Fees are non-refundable. I will follow times and all market rules & regulations. I will not set up my market more than 1 hour prior to the market start time. I understand failure to attend may result in my space (s) sold. Failure to provide complete application may delay processing and/or denial of the application. The Borough of Seaside Park reserves the right to limit the number of vendors, spaces per vendor, types of vendors, and vendor space locations. Spaces will be set by first come basis on the market's start date. Your space for the season will be designated the first market date attended. Failure to comply with the above rules and regulations may result in a non refundable eviction. I understand no vendor may block or park in front of the 9/11 clock.
