6. New business

Garbage pick on Saturday: town is still using permits for tenants to leave garbage at DPW on Saturdays from 8 -10 am when leaving rentals.

Town exploring services with SSH, they have “holding permit” to keep garbage over weekend for OC disposal. To be pursued for 2017 season.

Negative feedback from tenants, garbage is often left at the curb resulting in litter and public complaints. Sherry has asked owners to provide black trash bags.

Proposal from Realtors and town for pick up for rentals only on Saturday morning. Not all Realtors responded, but may be pursued again for 2017.

EC to inquire about what is wording of Municipal Code regarding trash, does it need to be posted in all rentals? Is there any enforcement or fines? Denise will bring code to Sept. Meeting.

Sherry asked about status of Beach Badges for tenants. Is it correct for landlords to purchase? General agreement that any change would be impossible to enforce.

Watering schedule for barrels at 14th Ave., sign up sheet passed for remainder of summer.

Maureen asked about sightings of “clinging” jelly fish. Greg will follow up and prepare report.

Greg has been participating in Kayak the Edge reporting for BBP survey. Will let EC know about results from survey after SSB annual meeting on 7/14/16. This information could go on the EC website, and be given to Mike Tierny to read at Council meetings.
