Ms. Liguori commented it will help workers who can now take their computers to the beach. Ms. Contessa noted it will help residents who will not incur normal phone charges.

The following Council committee reports and announcements were given. Chief Larkin reported a good attendance at the monthly Neighborhood Watch meeting. He noted that parking kiosks and meters were reinstalled and are now in effect.

Mayor Matthies attended a local school board meeting where a feasibility study was presented with the hopes of sending our elementary school children to the Lavallette school district.

Mr. Tierney reported for the Finance Committee that the Finance Department continues to work thru this year's budget reports including operating expenses.

Ms. Koury reported for the Operations Committee that she attended a meeting regarding the new affordable health care law that will affect all personnel. The administration is currently working to bring badge sales online. Ms. Koury also commented the planned beach replenishment program is now on hold.

Ms. Contessa announced the Environmental Committee's upcoming public information sessions. The Committee is also planning to build a 'butterfly station'' at the 14th Avenue pier.

Public Comments

Pat DeGutis Stockton Avenue, thanked the Council for approving the funding for wifi in town and inquired how soon it will be operational. Mr. Martucci explained he hopes to have it up on the beach by Memorial Day and then phased throughout the town.

Cheryl Borton, North Ocean Avenue, inquired whether the town will be involved with the June 6th music concert in Seaside Heights. Mr. Martucci explained he just met with the program managers who plan to ask for use of our borough's parking lots as a bus depot. More discussion is planned.

There being no further business, the meeting was adjourned at 9:54 p.m. by unanimous vote of the Council.
