Mayor Matthies explained that although the governing body normally sits at the front table for our work sessions, this meeting will take place on the dais due to the number of resolutions to be addressed as it is timely and for the good and welfare of our community.

Mayor Matthies announced that at this time of the year, Ocean County annually allocates dune grass for planting that is scheduled to take place this coming Saturday, November 14th. He also noted that an all-day seminar hosted by the Barnegat Bay Partnership on responsibility and research of "What lies beneath Barnegat Bay" will take place next Tuesday. Mayor Matthies along with Borough Administrator Martucci is currently in discussion with an outreach group 'flood risk' company to host an educational seminar and counsel one on one. Public Comments

Jim Jablonski, N Street, thanked council for their recovery efforts since the storm and inquired whether the NJDOT application is to reconstruct curbing along N Street. Mr. Tierney explained this resolution is acceptance of the grant for necessary repairs on N & O Streets. Mr. Jablonski hoped the reconstruction will include tradition curbs and not 'rolling curbs'. Dr. McHugh would like to hear more from N Street neighbor's thoughts on the type of curbing so he can bring it to the Operations Committee.

Andrea Lucarelle, N Street, inquired the status of the N Street road reconstruction project. Mr. Martucci explained it fell off the schedule due to Superstorm Sandy and it is now rescheduled. She hoped the bulkhead reconstruction will be completed prior to sidewalks and curbing. Mr. Martucci noted the bulkhead area needs to be dredged prior to reconstruction.
