The following Council committee reports and announcements were given.

Mr. Tierney reported for the Finance Committee and reaffirmed that the borough has had a A+ rating since 2011. He also reported he attended an informational session with Mayor Matthies regarding a governmental energy aggregation service. He will invite the company to our next work session.

Ms. Liguori further noted that Plumstead has been in this program for some time and that there is a considerable savings. She will reach out to Plumstead in order to gain more information.

Ms. Koury reported for the Operations Committee that she continues to work with our Stormwater Coordinator for filing our annual report. Additional projects her committee is reviewing are updated public informational pamphlets such as: bike safety; beach fire pamphlet, rental permit pamphlet; also review of ordinances to include penalties to tampering with water meters; peddling & solicitation; and Coastal A zone.

Ms. Liguori would like to take part in department budget reviews along with our CFO. She also plans to attend the scheduled CRS review on February 29<sup>th</sup>; noting that any improvements help us with a higher insurance rating that will lead to lower rates.

Ms. Coleman reported she plans to attend a negotiations meeting with Seaside Heights and Berkeley Township in order to receive additional funding/new vehicle for Tri-Boro First Aid Squad. Ms. Coleman also reported she attended a board meeting at Central Regional and they plan to create a "Health & Wellness" Center.

## **Public Comments**

Al Vassallo, Central Avenue, announced this is the second anniversary for Charlie Martowlis passing. He hopes the borough will take action to create a memorabilia room commending Charlie for his photography work in recording town happenings through photo. He recalled possibly having a room at the school. He implored Mayor Matthies and council members to pursue this. Chuck Appleby, Tenth Avenue, noted the new Coastal A zone does impact our town and that there are approximately 300 homes affected. Ms. Koury commented she attended a FEMA meeting in Eatontown along with borough officials who keep us informed as we move through this process.

Stevie Kizukewicz, Seventh Avenue, inquired road work along Route 35. Ms. Coleman explained the State continues to video sewer lines in order to correct deficiencies. Ms. Kizukewicz also wondered if we can have County workers help make sand bags for along the bay.

Mayor Matthies closed the public portion.

## Adjournment.

There being no further business, the meeting was adjourned at 7:50 p.m. by unanimous vote of the Council.
