## SEASIDE PARK BOROUGH COUNCIL

The Work Session of the Borough Council of the Borough of Seaside Park was called to order at 7:00 p.m. on Thursday, August 11, 2016 in the Borough Council Meeting Room located at Sixth & Central Avenues, Seaside Park. Mayor Matthies remembered Councilman McHugh who is recovering from a serious surgery.

"In accordance with the requirements of New Jersey's Open Public Meetings Act, public notice of this meeting was included in the required Annual Meeting Notice which was filed in the Office of the Seaside Park Borough Clerk; posted on the Bulletin Board located in the Municipal Building; and forwarded to the Asbury Park Press, the Star Ledger and to all persons requesting notice and providing self-addressed, postage-paid envelopes."

Council members reviewed a presentation from Ms. Sherry Villano regarding annual summer Saturday garbage permits. Ms. Villano suggested perhaps a better program is to have Saturday garbage pickup as it will be beneficial to seasonal renters as she feels the renters are not cooperating with the current permit program. This is due to the allotted time to drop off the household garbage. Ms. Villano inquired why the borough cannot dump their garbage in the Seaside Heights transfer station. Mr. Martucci explained this is not an option as they do not have an approved "transfer station". Ms. Liguori suggested DPW Supervisor review and make suggestions.

Council members also reviewed Chief Larkin's report to grant a handicapped parking space at 120 Fifth Avenue as the property owner was granted a disabled parking permit. Currently the property has a conforming driveway including a small garage that can service at least three off-street vehicles. The property is rented seasonally. Council members were not in favor of amending the ordinance to grant a handicapped space in front of 120 Fifth Avenue due to the available off-street parking.

The following Council committee reports and announcements were given.

Mr. Tierney reported for the Finance Committee they are currently looking into additional funding request from Tri-Boro First Aid Squad. Before any decision is made, their committee will have to understand their financial situation.

Ms. Coleman reported there is a workshop scheduled in order to be eligible for firefighter grants program. She also reported the new fire truck funded by Berkeley Township is ready for delivery to our fire house.

Ms. Koury reported the Operations Committee the memorial bench and plaque fees are ready to ordinance introduction. The committee met with borough engineer Savacool from T&M who reported on the status of the Lake Avenue, M Street and 14th Avenue bulkhead replacement project. Ms. Koury also reported the borough now has a Wi-Fi maintenance agreement.

Mayor Matthies reported he attended a meeting regarding the problems with the Mathis bridge as it continues to get stuck tying up summer traffic. He also attended The Save Barnegat Bay sponsored student research program hosted by the Borough.
