Mr. Tierney reported the parking kiosks will become non-operational and removed for the winter months as it will provide relief for our residents and visitors and also protect the machines from the winter elements. He hopes to begin budget review in order to present the 2017 budget early 2017.

Ms. Coleman complimented Detective Bonner on his swift actions caused by the September 17th bombing.

Ms. Koury reported for the Operations Committee that NJ Gas Company will begin road work on the Boulevard soon and the project will provide additional gas service to the island. We will continue to work with to complete the permitting process for the Bayfront study grant. Her committee continues to review the decommissioning of Well #7 and bring Well #10 on line.

Mayor Matthies commented the Phase I of the environmental impact study will receive grant funding; along with Phase II that will be reimbursed by FEMA. Mayor Matthies thanked the Beautification Committee, Administration, Police and Fire Departments for their participation with the 911 observance. Mayor Matthies acknowledged the newspaper report on Ocean County municipal water quality reports and stated he spoke with our Water Superintendent who confirmed we usually have a good reading that falls below the national standards and this situation should not get neighborhoods in a panic. Mayor received a thank you note expressing a fantastic summer season in Seaside Park. Also the second year of the bridge work will begin again on Nov. 1st.

Mayor Matthies also thanked the local, County, State and Federal Departments for their diligent work after the September 17th bombing that occurred on D Street.

Public Comments

Stevie Kizukiwicz, Seventh Avenue, inquired whether public hearings will be held on the new Master Plan. Mayor Matthies assured her there will be a number of opportunities for public comments.

Mayor Matthies closed the public comment portion.
