SEASIDE PARK BOROUGH COUNCIL

The Work Session of the Borough Council of the Borough of Seaside Park was called to order at 7:05 p.m. on Thursday, November 10, 2016 in the Borough Council Meeting Room located at Sixth & Central Avenues, Seaside Park. Mayor Matthies asked all to stand for a moment of silence and led the Pledge of Allegiance remembering those who serve in the Armed Forces to protect our country. He asked we remember the passing of former Seaside Park Board of Education Member Dan Clayton, and also Eugene Raftery, the father of our Tax Assessor.

Mayor Matthies acknowledged today is the Marine Corp birthday, and tomorrow is Veteran's Day. Mayor Matthies welcomed Council-Elect Ray Amabile to our work table.

Mr. Tierney reported for the Finance Committee the introduction of a bond ordinance for the decommissioning of Well #7 and construction of a treatment facility for Well #10. Mr. Tierney explained this is funded in part by a grant, and a low-interest loan with a thirty-year maturity date. The loan will amount to approximately \$7 to 8.00 per household per year.

Ms. Koury reported a recommendation from the Planning Board for 3 ordinances to amend our Development Regulations resulting from our re-examination report of our Master Plan. The amendments will be to the 'boardwalk' and 'business' zone, and also general definitions.

Chief Larkin reviewed a request for a handicap parking space for a resident who rents an apartment at 905 SW Central Avenue and is not afforded an off-street parking space. Chief Larkin explained the only verifiable relief is to allot one space in the center median. Council felt relief should be granted and to petition NJDOT for a "TRO".

Council reviewed a request from Chief Larkin for a refund due to an overpayment of a parking kiosk.

Council reviewed a request from the Seaside Park Environmental Advisory Committee to reduce member term limits from three to two years. Council thanked the committee for their efforts over the years.

Council reviewed property maintenance information provided by Mr. Zabarsky that addresses the borough's ability to seek enforcement with property held in the name of a partnership, corporation or limited liability company. Mr. Tierney noted neighbors are frustrated due to the lack of support to have the Central Avenue property cleaned up and we have the responsibility to make sure the proper steps are taken since this particular property has been vacant for 4 years. Mr. Zabarsky will issue a draft for council's consideration. Ms. Koury supports this and hopes it will help clean up problem properties.

The following Council committee reports and announcements were given.

Mr. Tierney reported for the Finance Committee that department budgets are being put together to begin review November and December and hopes to introduce next February 2017.

Ms. Koury reported for the Operations Committee that the boardwalk temporary wooden railings will soon be replaced with stainless steel. The police department researched handicap parking for St. Catharine's for the side streets and council will consider formal action tonight. Ms. Koury announced our code officer has taken a position in another town.

Police Chief Larkin reported the Neighborhood Watch November meeting will be next week. It will include a driver's refresher course through AARP. The annual Christmas tree lighting and Neighborhood Watch holiday party will be held on Sunday, December 4th.

Mayor Matthies reported the annual dune grass planting was held last Saturday. He remarked on the Garden Club's autumn display at the north end of town.

There were no "Use of Boro Facilities" requests for Council's review.

No Public Comments were offered.

Council took a 5 minute recess.

Council reconvened at 7:40 pm.
