## **ORDINANCE NO. 1637**

AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK, OCEAN COUNTY, NEW JERSEY, AMENDING CHAPTER 200 ENTITLED "DEVELOPMENT REGULATIONS" TO ESTABLISH A LIMITATIONS PERIOD ON VARIANCES.

**WHEREAS,** Ordinance 1637 of the Borough of Seaside Park established a combined Planning Board pursuant to N.J.S.A. 40:55D-23 and 25c; and

WHEREAS, said ordinance repealed the limitations period for certain variances set forth in Borough development regulation section 200-7E (formerly 25-404E) as part of its abolishment of the former Zoning Board of Adjustment; and

**WHEREAS**, said ordinance repealed subsections A, B, C, D, and E of Borough development regulation section 200-16 (formerly 25-414) as part of its abolishment of the former Planning Board; and

WHEREAS, the Council is desirous of reestablishing a limitations period applicable to bulk variances and use variances as the passage of time may result in certain development being less compatible with the zone plan, and can eliminate the mitigating factors in support of a variance grant; therefore, further review by the Planning Board is necessary and appropriate.

**THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Seaside Park, County of Ocean and State of New Jersey as follows:

**SECTION 1.** Section 200-16 of the Code of the Borough of Seaside Park entitled "Provisions Applicable to both Board of Adjustment and Planning Board" is hereby amended as follows:

- 1. Section 200-16 shall be renamed "Additional Planning Board Provisions"
- 2. Subparagraphs F, G, and H shall be re-lettered as A, B, and C respectively.
- 3. A new subparagraph D shall be inserted as follows:

Expiration of Variance. In the granting of bulk variances under N.J.S.A. 40:55D-70c and use and/or density variances under N.J.S.A. 40:55D-70d, a time limitation of two (2) years from the date of approval shall be set within which the owner shall secure a building permit, otherwise the variance granted shall be null and void. The approving authority may for good cause shown extend the period for securing a building permit for an additional six month period.

**SECTION 2.** All other ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

**SECTION 3.** In the event that any portion of this ordinance is found to be invalid for any reason by any court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the ordinance actually adjudged to be invalid, and the remaining portions of this ordinance shall be deemed severable therefrom and shall not be affected.

**SECTION 4.** This ordinance shall take effect upon final passage and publication in accordance with law.
