ORDINANCE NO. 1656

AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK, OCEAN COUNTY, NEW JERSEY, AMENDING CHAPTER 200 ENTITLED "DEVELOPMENT REGULATIONS"

BE IT ORDAINED by the Borough Council of the Borough of Seaside Park, County of Ocean and State of New Jersey as follows:

SECTION 1. Section 200-40 of the Code of the Borough of Seaside Park entitled "Fences and Walls" is hereby amended in subsections C and D (underlined); and supplemented with a new subsection G as follows:

- C. Front Yard Setback Area. No fence constructed under this section within the front yard setback area of any lot <u>developed with a one or two family dwelling</u> shall exceed four feet in height. Any portion of the fence that exceeds three feet in height must remain fifty percent (50%) open to light and air. By way of example, a four foot fence may consist of a three foot solid fence with a one foot open air portion above the solid portion. Any portion of the fence that is more than three feet above adjacent grade must remain at least fifty percent (50%) open to light and air. By way of example, a four foot high fence may consist of a three foot solid portion with a one foot portion above the solid portion that is at least (50%) open to light and air.
- D. Waterfront lots. Notwithstanding any provision of this section to the contrary, in cases in which the developer's lot fronts on a body of water and is developed with a one or two family dwelling, any fence constructed within 15 feet of the water shall not exceed four feet in height. Any portion of the fence that exceeds three feet in height must remain fifty percent (50%) open to light and air. By way of example, a four foot fence may consist of a three foot solid fence with one foot open air portion above the solid portion. Any portion of the fence that is more than three feet above adjacent grade must remain at least fifty percent (50%) open to light and air. By way of example, a four foot high fence may consist of a three foot solid portion with a one foot portion above the solid portion that is at least (50%) open to light and air.
- G. The height limitations provided for in this section shall be applicable to lots developed with residential uses only. G. Commercial Trash Enclosures. Notwithstanding any provision of this section to the contrary, a six foot high solid fence shall be required around areas serving a commercial trash collection purpose.

SECTION 2. All other ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

SECTION 3. In the event that any portion of this ordinance is found to be invalid for any reason by any court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the ordinance actually adjudged to be invalid, and the remaining portions of this ordinance shall be deemed severable therefrom and shall not be affected.

SECTION 4. This ordinance shall take effect upon final passage and publication in accordance with law.
