Installation fees are based on the installation of up to forty (40) feet of service line from the utility main to the curb in front of the property to be served. Fees for additional lengths shall be prorated per foot or portion thereof. In addition to the service connection fees, the property owner shall also be responsible for the payment of fees and permits required for service installations on a County or State road.

SERVICE DISCONNECTIONS REQUESTED. Temporary Service Disconnection at the curblin is necessary in order to receive demolition or elevation permits. Temporary service disconnection **does not terminate billing for utility service.** Termination of Service involves the permanent disconnection of the service line at the utility main and terminates billing. In addition to the termination of service fees, the property owner shall also be responsible for the payment of fees and permits required for service terminations on a County or State road. Reconnection after the termination of service requires the installation of new service connections in accordance with the Service Installation section above.
