- SUMMER TRAILER STORAGE** (April 1st - October 31st) Fee: \$150.00 + Tax
(Any trailer parked exceeding the storage period shall pay the daily fee of \$5.00 per day)
- WINTER TRAILER STORAGE** (September 15th - June 15th) Fee: \$150.00 + Tax
(Any trailer parked exceeding the storage period shall pay the daily fee of \$5.00 per day)
- SUMMER TRAILER & BOAT STORAGE** (April 1st - October 31st) Fee: \$20.00 per foot + Tax
(Any boat on a trailer parked exceeding the storage period shall pay the daily fee of \$10.00 per day)
- WINTER TRAILER & BOAT STORAGE** (September 15th - June 15th) Fee: \$22.00 per foot + Tax
(Any boat on a trailer parked exceeding the storage period shall pay the daily fee of \$10.00 per day)

TRAILER & TRAILER/BOAT STORAGE REGULATIONS: The trailer registered in this Agreement is the only trailer authorized for storage unless prior written approval is obtained from the Borough of Seaside Park. Subleasing or transfer of Trailer Storage authorization is not permitted. The Borough of Seaside Park reserves the right to reassign Trailer Storage locations. **Boats must be stored uncovered, have custom covers, or be professionally shrink-wrapped. No tarps will be allowed to cover boats.**

SECURITY: There is no on-site security provided by the Borough of Seaside Park. The Borough is NOT responsible for your boat (or trailer) or other personal property. It is recommended that you provide adequate insurance coverage.
