RFQ for Weed Control 2024 & 2025

The Borough of Seaside Park is seeking price quotes for weed control for the 2024 & 2025 season. (2 yrs)

The RFQ must be completed as provided herein with individual pricing, failure to comply will negate the quote. All quotes must be received by March 29th, 2024. This form can be faxed to 732-606-5123 or emailed to ewoj@seasideparknj.org

The contract award for weed control will be for five (5) applications in 2024 & five (5) applications in 2025 or as needed through September of each year.

Free service calls as needed shall be included for areas missed during applications. Areas that do not require treatment shall be skipped and not billed.

Special care shall be taken to avoid overspray and damage to existing grass and landscaping plants, as well as adjacent properties.

- Vendors are required to submit a N.J. Business Registration Certificate and W-9 if business has not previously conducted business with the Borough of Seaside Park
- Vendors are required to submit a certificate of insurance naming the Borough of Seaside Park as an additional insured and showing they provide Worker's Compensation Insurance.
- Vendors are required to comply with all Labor Laws of the State of New Jersey.
- Vendors must supply GHS Safety Data Sheets for applied chemicals
- **The vendor must give 3 days of advanced notice for all applications and contact the DPW Supervisor at 848-992-1918** when applications are being applied. **Flags with the date of application** shall be placed at each location.
- The vendor shall schedule applications early in the day as not to interfere with the general public (i.e parking lots, parks, etc.)

Please see the attached color maps for specific names and locations of the areas to be treated for weed control. General areas to be treated are highlighted in purple and may not include all areas that grow weeds to be treated. 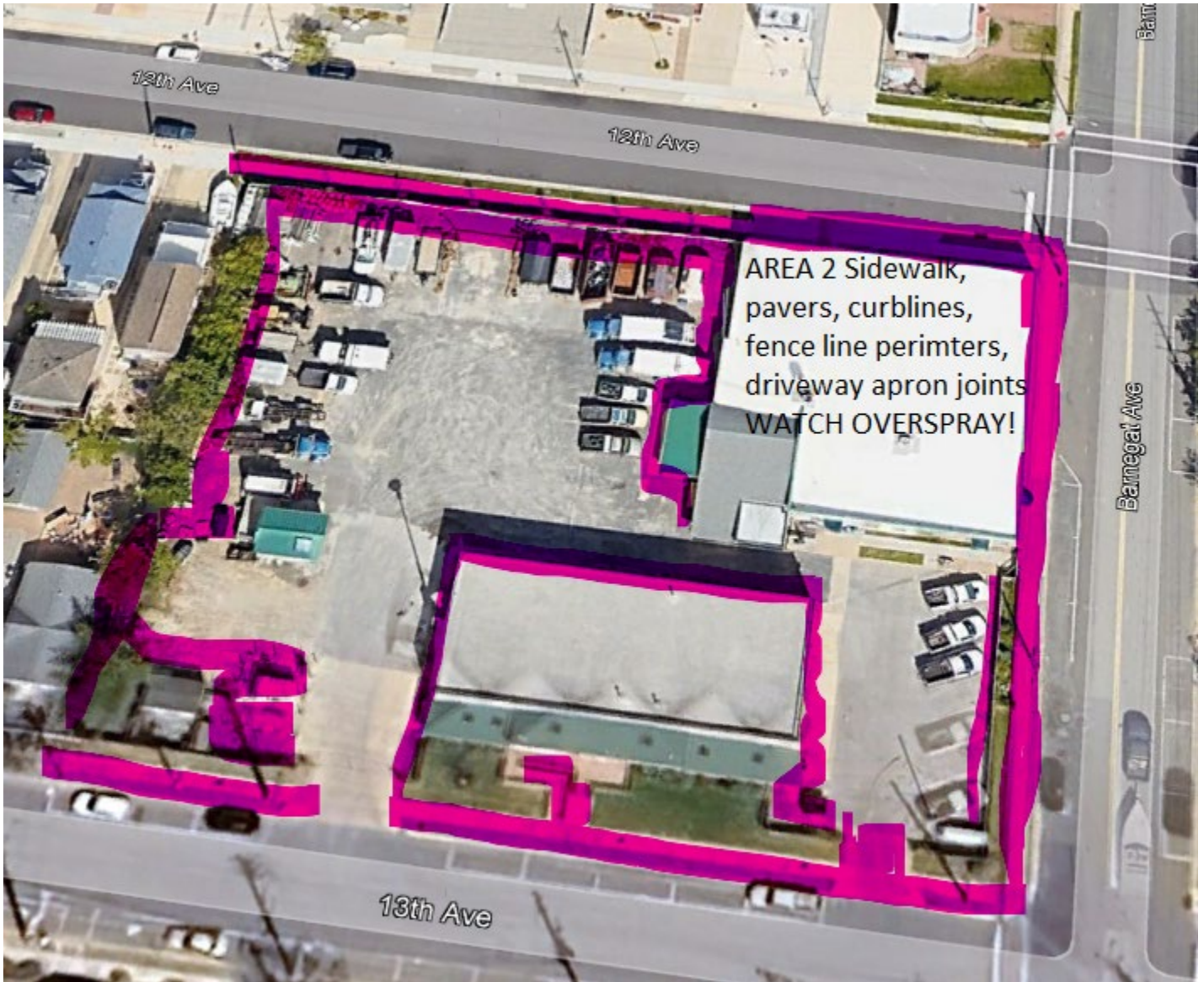
1. Moe Levine Park (13th- 14th Ave & Barnegat Ave) \$_____per app

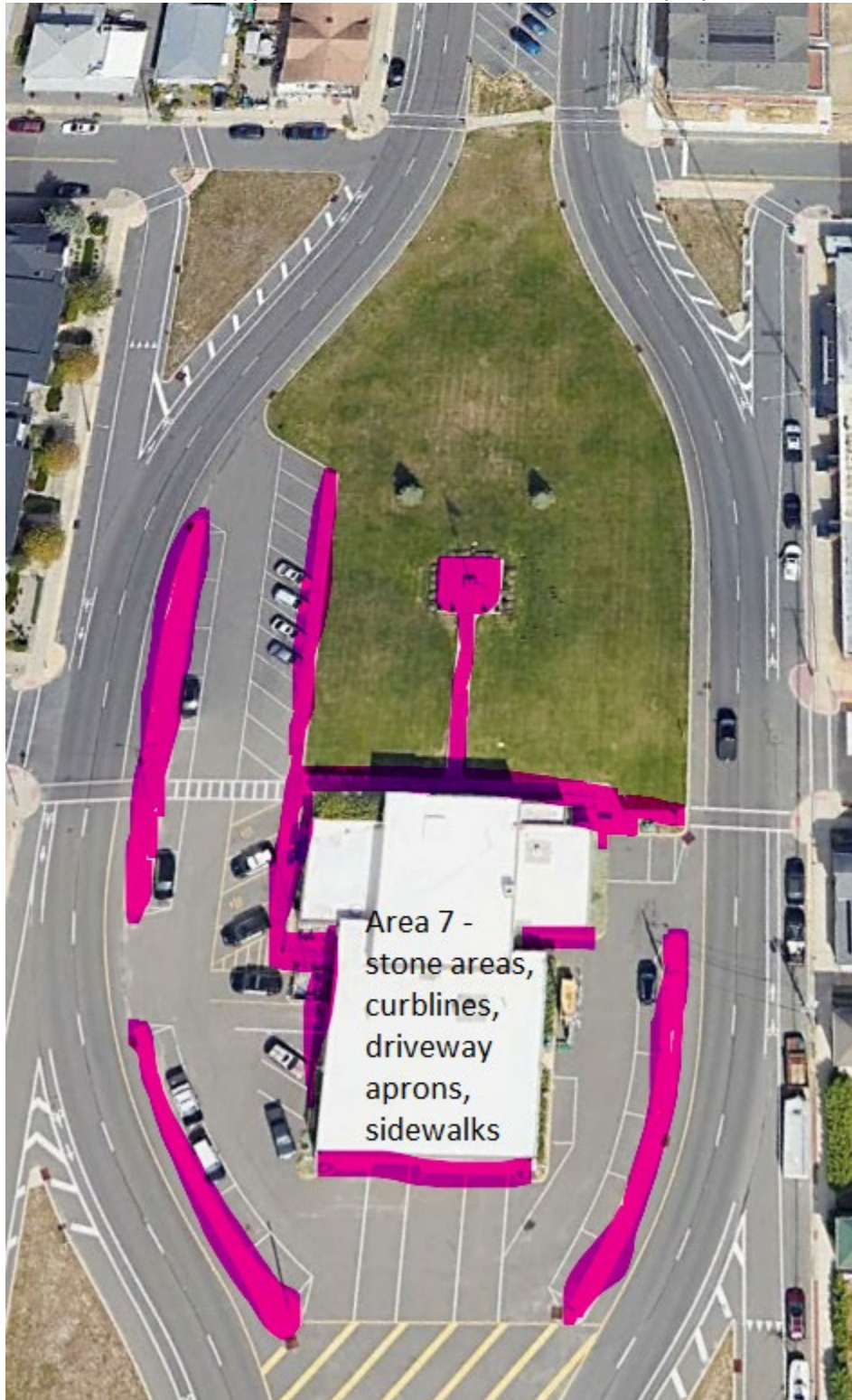
a. Fence line, trex decked walkways

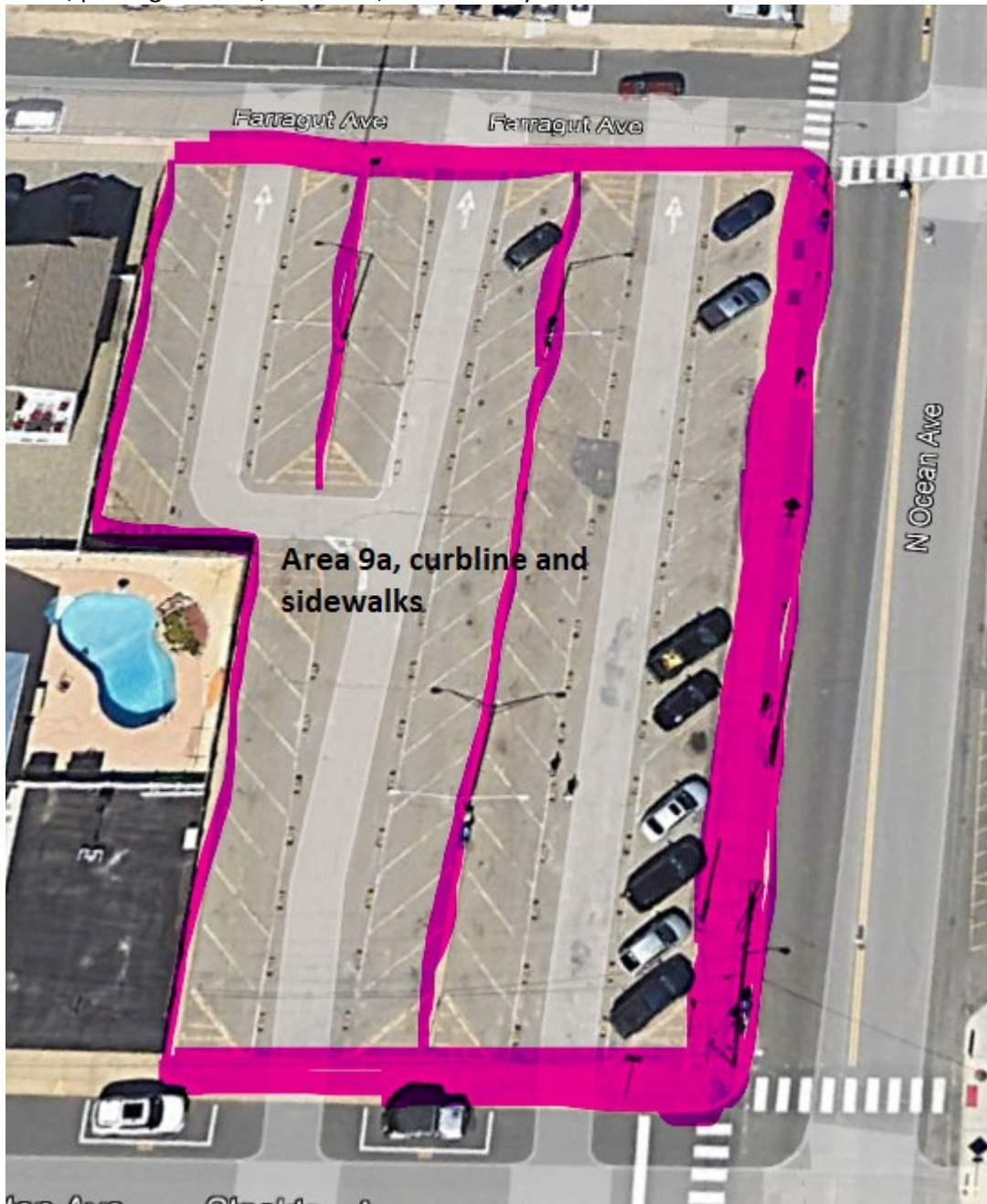
- a. Parking area where needed, curb, sidewalk, area between curb & sidewalk, and fence line

a. Curbs, parking medians, sidewalks, trex walkways



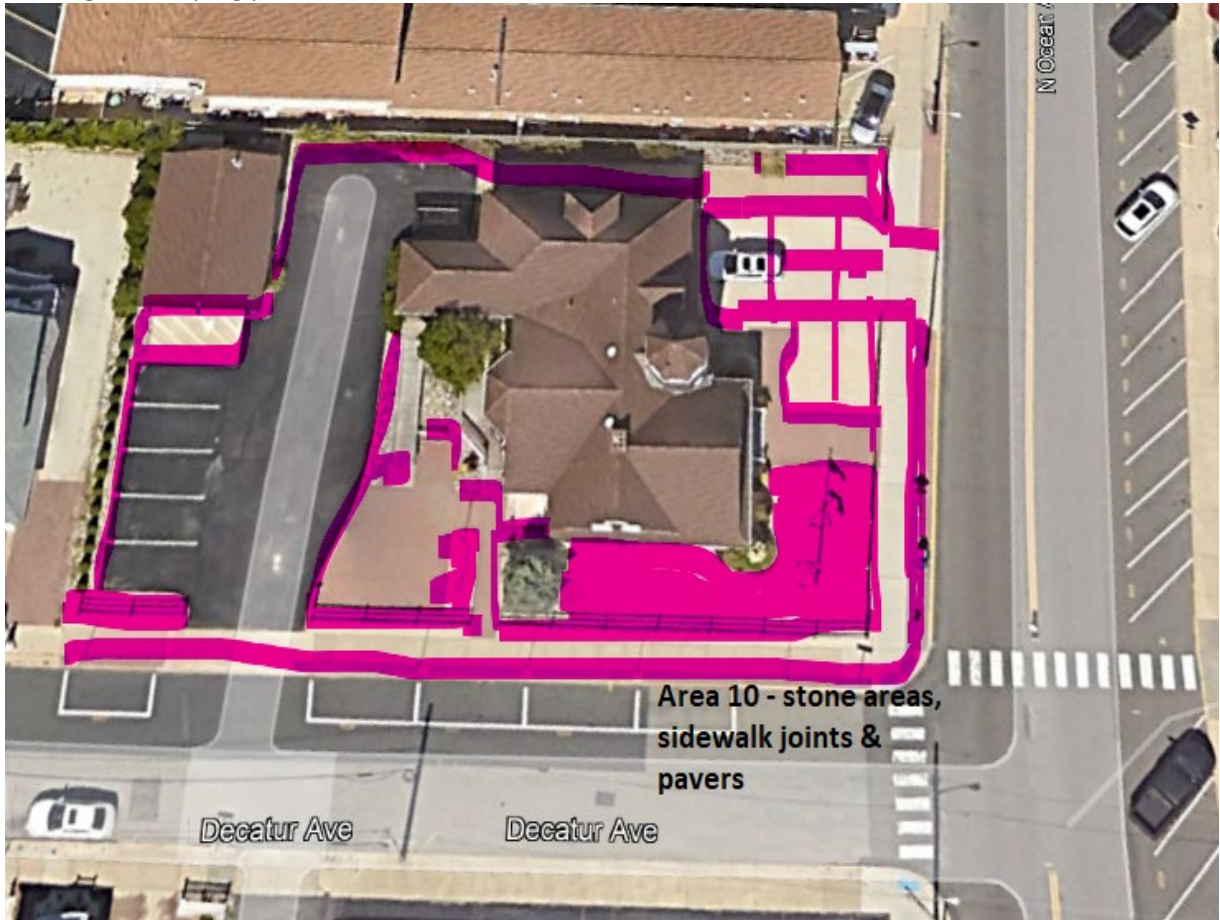




10. Seaside Park Borough Hall (1701 North Ocean Ave)

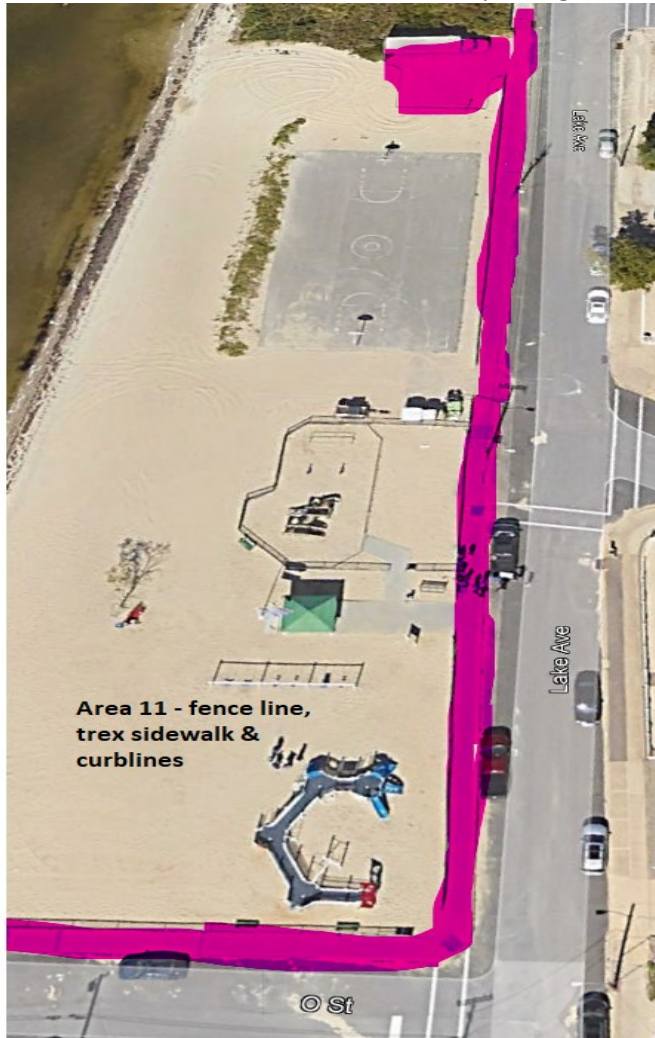

 a. Curb, trex walkway, along bulkhead

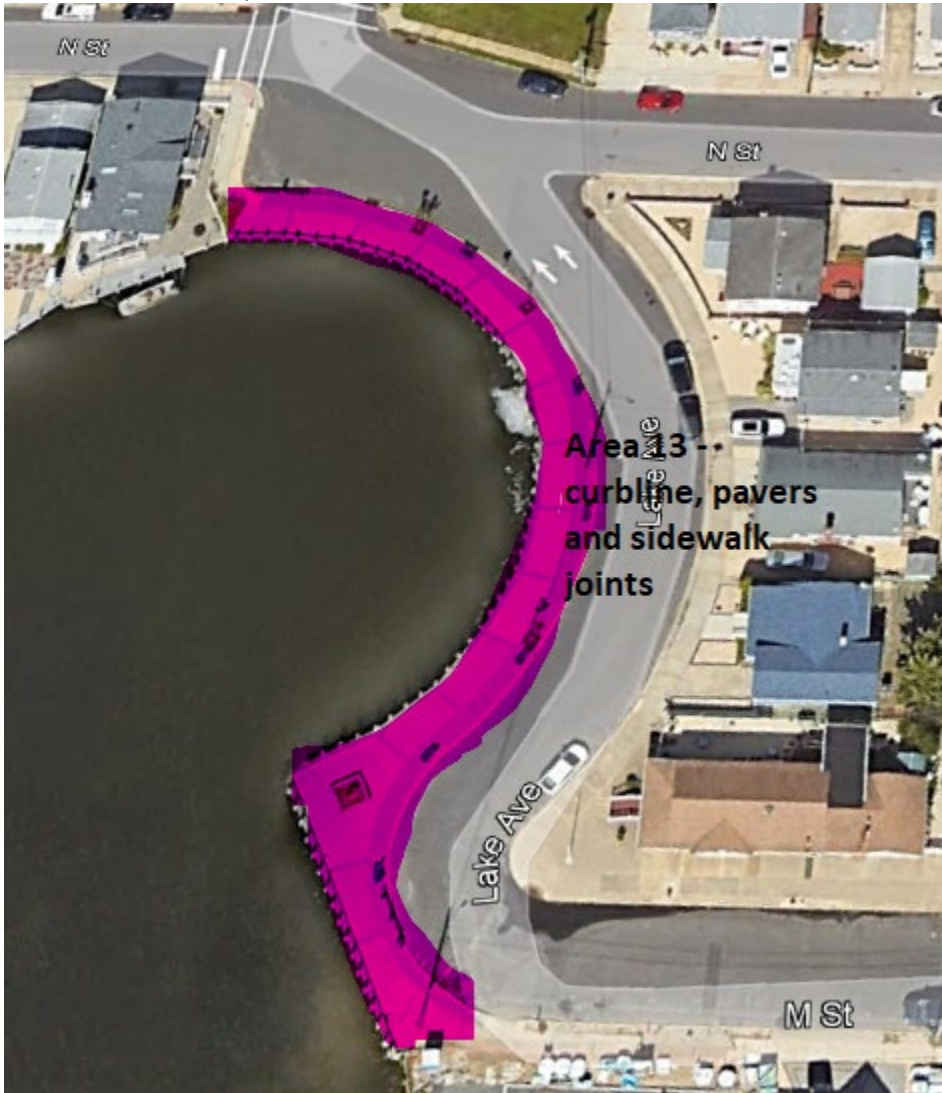
